Membership Current Rule

Clause 4

4) Life members may be elected by the Annual Meeting of the Association and are to be persons who have conferred signal benefit of the Association.

To be replaced with

Life Membership. Clubs should address the guidelines. The SAHPA COM shall review the nomination to ensure consistency The rules and conditions for life membership can be found in the Current Clause

Proposed Clause

Clause 4

4) Life members may be elected by the Annual Meeting of the Association and are to be persons who have conferred signal benefit to the Association. A notice proposing life membership nomination shall only be accepted from:

1). Affiliated clubs of the Association which have discussed and approved the proposal(s) by a majority of members attending an official club meeting at which a quorum was present; or

2). The SAHPA Committee of Management.document- SAHPA Guidelines for of nomination prior to SAHPA members voting on the nomination at the next available AGM

Current Rule :

Rule 22. Committee of Management

18) The Committee of Management shall have power at any time, and from time to time, to appoint any other person as a member of the Committee of Management to fill a casual vacancy or as an addition to the Committee so that the total number of members of Committee at any time shall not exceed the maximum number fixed. Any member so appointed shall be a member of the electorate from which the vacancy arose, and may hold office for the year in which he/she was appointed and shall retire at the end of that year, but is eligible to nominate for re-election at the next Annual General Meeting. Such member may nominate for one more consecutive three-year term after completion of their first full term in office.

To be replaced by :

Rule 22. Committee of Management

18) The Committee of Management shall have power at any time, and from time to time, to appoint any other person as a member of the Committee of Management to fill a casual vacancy or as an addition to the Committee so that the total number of members of Committee at any time shall not exceed the maximum number fixed. Any member so appointed shall be a member of the electorate from which the vacancy arose or if no one from that electorate is willing to be appointed then the Committee of Management can appoint a member from another electorate, and may hold office for the year in which he/she was appointed and shall retire at the end of that year, but is eligible to nominate for reelection at the next Annual General Meeting. Such member may nominate for one more consecutive three-year term after completion of their first full term in office.

Current Rule RBL 21

That there are no qualifications for birds on all SAHPA races.

To be replaced with :

RBL 21 Young birds competing in SAHPA Races (middle and long distance) must have had at least one club race on the line of flight before being entered in any SAHPA race, including Special Races. Club secretary's to keep all club nomination sheets and check all SAHPA positions from their respective clubs and advise the SAHPA Race Adjudicator that the birds have been qualified for the SAHPA races. Any bird where the club does not have proof that it competed in a club race will be disqualified.
