1. Attendance: Mr G Harris (Chairperson),
Mr J Cock, Mr P Squire, Mr T Fawcett, Mr P Springett,

Guests M Kovacevic, P & R Langer, V Curea from Smithfield Club re threats to SAHPA and Officials.

2. Apologies – None

3. The Smithfield Club confirmed they had the required 6 members on the night of hampering.

4. The evidence presented: Mr V Curea rang Mr P. Squire while he was on the road, in regards to the Morundah hold over and made threats if the birds from his club were released the SAHPA would be reported, he was then advised to contact Mr T Fawcett and explain his request that the Smithfield Clubs pigeons were not to be released on account of the winds on the next day being from the NW and not the SW with no consideration of the rain which was the reason the Release Panel requested the birds be held over and the SAHPA COM was in agreeance with the Release Panel. After a heated discussion between the two parties Mr V Curea made a threat to the SAHPA Management Committee if the birds were to be released we would be reported if the Smithfield club birds were not brought home. Subsequently the Chairperson Mr Gavin Harris was contacted by the head Release Officer and he advised that the crates should be resealed and not released and brought back to Adelaide for the Smithfield club to pick up, the members making the threat were then requested to appear before the management committee on the above date.

Based on the threat by V Curea of the Smithfield Club to the SAHPA inc the Committee of Management have invoked the following sentence based on Rule 9.2.a & e) Termination of Member.

- 1) Partnership of Curea & Langer membership will be terminated for the remainder of season 2016.
- 2) Partnership of Curea & Langer will serve a twelve month good behaviour Bond for season 2017.

Any breach of this Bond will incur the full twelve month membership termination and no claim for any refund of membership or bird pre-payment will be considered.

5. Roslyn Langer's written defamation email sent to Mr Gavin Harris SAHPA Chairperson as an email reply from Roslyn (P & R Langer), the Committee of Management have invoked the following sentence based on Rule 9.2.a Termination of Membership.

- 1) Roslyn Langer of partnership P & R Langer will have her Membership suspended for the remainder of season 2016 and all of season 2017.
- 2) Roslyn cannot hold any official position in any SAHPA Club that may involve liaising with any SAHPA Official.
- 3) Peter Langer may race in his own name in season 2017.
