SAHPA PMV VACCINATION RULES

MEMBERS LOFTS

The South Australian Homing Pigeon Association (SAHPA) has a policy of mandatory vaccination for PMV of all pigeons by members of the SAHPA. Affiliated members who plan to transport pigeons on the SAHPA training and race units must also comply with this policy.

SQUEAKER SALES AT SAHPA HEADQUARTERS AND AT ASSOCIATED CLUB ROOMS

All pigeons in squeaker sales must have had their first vaccination for PMV before the sale. Persons submitting pigeons for sale must present to the sale organisers a SAHPA PMV Form 1 specifying the date the first vaccination was given. The form is to be given to the purchasers of the pigeons who are responsible for conducting the second vaccination.

SIRES PRODUCE

All pigeons auctioned for the Sires Produce must have had their first vaccination for PMV before the auction. Persons submitting pigeons for auction must present to the sale organisers a SAHPA PMV Form 1 specifying the date the first vaccination was given unless this information is included in the breeders entry form. Purchasers of the pigeons are responsible for conducting the second vaccination.

Pre-paid nominations from country and interstate flyers must have had their first vaccination for PMV before delivery to the nominated flyer. A SAHPA PMV Form 2 specifying the date the first vaccination was given must accompany the pre-paid nomination form unless this information is included in the nomination form. The nominated flyers are responsible for conducting the second vaccination.

OTHER SALES AT SAHPA HEADQUARTERS AND AT ASSOCIATED CLUB ROOMS

All pigeons in stock and race bird sales must have completed the two stage PMV vaccination and the vaccination must be current. Persons holding sales at the SAHPA headquarters or in Club Rooms must present to the SAHPA or the Club, as the case may be, a SAHPA PMV Race Form 2 stating that the vaccination is current. Purchasers of the pigeons are responsible for conducting new vaccinations.

ONE LOFT RACES – ADELAIDE PIGEON CLUB AND THE ADELAIDE TEN THOUSAND

All pigeons entered into One Loft Races must have had their first vaccination for PMV before delivery to the lofts. Persons entering pigeons into One Loft Races must present to the Loft Managers a SAHPA PMV Form 2 specifying the date the first vaccination was given. The Loft Managers are responsible for conducting the second vaccination.
