5. **One Loft Race 2026 Budget discussion.**
 - 5.1 COM agreed that development would be subject to council approval for a bird aviary.
 - 5.2 COM agreed to update the budget to allow for 300 one loft entries,
 - 5.3 COM agreed to create a separate entity for the one loft race, name to be agreed later
 - 5.4 COM agreed to present a budget of \$30,000 for a custom built loft. The plan is the SAHPA would lend \$30,000 for the loft build and then have \$10,000 paid back each year for 3 years, after year 3 the one loft race entity will pay \$6,000 to SAHPA which will be applied to decreasing the Prepaid price each year. That is a 20% return each year from year 3 onwards.

6. Prepaid Price per bird discussion – review Life Rings

Discussed forecast to apply \$12,000 towards Prepaid. For example, If we get 19,000 prepaid nominations this would reduce the cost to \$2.10 per bird.
